Doctorate in Business Administration

DBA in International Business

The DBA is a research Doctorate in Business Administration, which aims at making a contribution to both management practice and theory. The dissertation may result in a journal publication.

The learning objectives of this Degree are to provide high quality skills and the required knowledge for Company Leaders and Executive Managers. The DBA structure at Horizons University is made up of core and elective courses. These courses are spread out through the three years, and the dissertation is only written during the second and third year. During their time at Horizons University, students will have to take Foundation Seminars. Students complete an independent dissertation in the last two years of their DBA. The dissertation supervisor is assigned to the doctoral student for guidance only after the Research Proposal is approved by Horizons University.

Duration

The DBA was designed to last 3 years (or 36 months). However, due to Horizons University's differentiating flexible approach to teaching, you can both accelerate your degree or adapt it to fit your personal responsibilities. This is possible because of the self-paced learning approach, where you complete courses at your pace, and you may begin new courses any day of the year - when you are ready.

Studying Options

It is possible to study both on-campus (in French) and online (in English).

Career Prospects

The DBA in International Business prepares students: for leadership positions in global organizations; for careers as independent consultants; to become entrepreneurs and business researchers.

Admissions Requirements

- A Bachelor and a Master's degree with a major related to Business.
- 3 years or more of business related work experience.
- **When studying online:** The candidate must have proficiency in the English language. When the candidate is not a native English speaker, has not completed a degree in English, or has not worked in English, the prospective student must have a TOEFL score of 500PBT/61IBT (or equivalent score in an equivalent English test).
- **When studying on-campus:** The candidate must have proficiency in French language. When the candidate is not a native French speaker, has not completed a degree in French, or has not worked in French, the prospective student must have a pass score in a French language test.

Foundation Seminars:

The Foundational Seminars are included in the DBA program to ensure that students all have a knowledge of basic business areas which are not covered in the Core Courses. These courses are required for graduation, and yield extra credit.

Foundation Seminars in:

- ◇ Business Ethics
- ◇ Marketing
- ◇ Finance and Accounting

Core Courses:

The core courses designed for the DBA enhance students' knowledge of research methods. The core courses specifically reinforce the business topics that are important for a DBA in International Business. These courses will develop the student's **critical thinking, communication skills, and global awareness** through internationally focused courses.

Electives:

The Elective courses are designed to increase the students' in-depth comprehension of topics in International Business. Examples:

- ◇ Emerging International Markets
- ◇ E-Commerce
- ◇ Multicultural Management
- ◇ International Human Resources Management
- ◇ International Marketing
- ◇ Marketing Strategy Development

Dissertation:

The dissertation is largely independent research and writing, completed under the supervision and guidance of experienced faculty.

The dissertation is composed of two phases:

Phase I: Research Proposal, which is developed during the "Business Research Methods" course. Once this is approved by the university, the student can pass to the second phase.

Phase II: Independent Research and Dissertation Writing


These two phases are done with two separate supervisors.

Viva:

The Viva is the final step of the DBA. At this stage the DBA Dissertation is defended in front of a jury.

Admissions Process

1. Application

First you must apply by filling in the application form, and sending Horizons University all the required documentation either via email or post.

2. Application Appraisal

Once you have submitted your complete application, Admissions will appraise your application and get back to you in one week with the results of the evaluation.

3. Enrollment to the University

Once accepted you will be eligible to enrol. The enrolment process is simple and fast. At this point you are required to send an original copy of your latest transcript to the central Paris campus, and pay your tuition. - Your resume (Curriculum Vitae).
- 1 passport-size photo
- Scanned copies of all diplomas and transcripts obtained to date
- Proof of language proficiency
- Copy of your passport.

Application and Enrolment Dates

You may enrol to the Horizons University DBA 365 days a year.

Once accepted, you can enrol to the DBA program anytime, and begin your courses any day, because courses have enrolment on a rolling basis.

Graduation

Diplomas are shipped upon successful completion of the degree. Students wishing to attend graduation on our campus should contact the university at least 6 months prior to graduation (every Summer).
